1 WHEREAS, the Gu Achi District has reviewed and considered to
2 amend its FY 89-90 budget; and

3 WHEREAS, the Gu Achi District FY 89-90 was \$172,394.76 and will
4 be amended by \$2,500.00 totaling for the new budget to
5 be \$174,894.76; and

6 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
7 proposed budget amendment and approves of same.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
9 Council that it hereby approves the Gu Achi District
10 Council budget amendment to be expended in accordance
11 with the attached budget.


12 The foregoing Resolution was passed by the Tohono O'odham Council
13 on the 8th. day of January, 1990 at a meeting at which a quorum
14 was present with a vote of 1,724.0 for; -0- against; -0- not
15 voting; and 03 absent, pursuant to the powers vested in the
16 Council by Section 1 (d)(3) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).



31 submittal.


