

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing the Water Resource Committee to Contact the Federal  
Negotiating Work Team on Indian Water Settlements on the  
Proposed Chui Chu Water Settlement)

RES. NO. 101-90

1 WHEREAS, the Tohono O'odham Legislature Water Resource Committee  
2 is the oversight committee on all water related issues of  
3 the Tohono O'odham Nation; and

4 WHEREAS, the Water Resource Committee is aware of the Department  
5 of the Interior's Criteria and Procedures established on  
6 March 12, 1990 on Indian Water Settlements; and

7 WHEREAS, the Interior Department has established a Negotiating Team  
8 to work directly with Indian Tribes to settle Indian water  
9 claims; and

10 WHEREAS, the Water Resource Committee is aware of the proposed Chui  
11 Chu Water Settlement; and

12 WHEREAS, the Sif Oidak District Council pursuant to District  
13 Council Resolution No. 05-90, supports the recommendation  
14 of the Water Resource Committee to contact the Federal  
15 Negotiating Team; and

16 WHEREAS, the Water Resource Committee is aware that a Tribal  
17 Resolution will be required and attached to the letter  
18 drafted by the committee.

19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
20 Council, hereby authorizes the Water Resource Committee  
21 to contact the Federal Negotiating Work Team on Indian  
22 Water Settlements on the proposed Chui Chu Water  
23 Settlement.

24 BE IT FURTHER RESOLVED that the Water Resource Committee make the  
25 initial contact within thirty (30) days of the enactment  
26 of this Resolution.

27 BE IT FINALLY RESOLVED that this Resolution will only be for  
28 contacting the Negotiating Team on the proposed Chui Chu  
29 Water Settlement.

30 The foregoing Resolution was passed by the Tohono O'odham Council  
31 on the 3rd day of April, 1990 at a meeting at which a quorum was  
32 present with a vote of 1,724.0 for; -0- against; -0- not voting;  
03 absent, pursuant to the powers vested in the Council by Section  
1 (j) of Article VI of the Constitution of the Tohono O'odham  
Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
