

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Job Opportunities Basic Skills Title II Budget Amendment)

RES. NO. 102-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the Job  
2 Opportunities Basic Skills (JOBS) Title II Program funded  
3 by the Department of Health and Human Services, Family  
4 Support Administration (DHHS/FSA); and

5 WHEREAS, any amendments affecting the funding or funding levels of  
6 the contract shall be submitted for review and approval  
7 by the Job Opportunities Basic Skills (JOBS) Title II  
8 Program; and

9 WHEREAS, an amendment has been submitted for review and approval  
10 by the Job Opportunities Basic Skills (JOBS) Title II  
11 Program; and

12 WHEREAS, an additional \$4,417.00 has been allocated to the Tohono  
13 O'odham Nation for a final total allocation of \$56,445.00  
14 for the period of January 01, 1990 through September 30,  
15 1990.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
17 Council that it hereby approves the amendment to the Job  
18 Opportunities Basic Skills (JOBS) Title II Program in the  
19 amount of \$56,445.00.

20 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
21 that the Tohono O'odham Nation's Officials, to wit: the  
22 Chairman, Vice-Chairman and any designated official are  
23 hereby authorized to negotiate and execute the contract,  
24 provided however, that any amendments affecting the  
25 funding or funding levels of the contract shall be  
26 submitted for further prior approval by this Council.

27 The foregoing Resolution was passed by the Tohono O'odham Council  
28 on the 3rd. day of April, 1990 at a meeting at which a quorum was  
29 present with a vote of 1,724.0 for; -0- against; -0- not voting;  
30 03 absent, pursuant to the powers vested in the Council by Section  
31 1 (f) of Article VI of the Constitution of the Tohono O'odham  
32 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
