1	WHEREAS, the Job Training Partnership Act (JTPA) funds are made
2	available to state and tribal governments from the United
3	States Department of Labor to establish employment and
4	training programs for improving the employment prospects
5	of eligible persons; and
6	WHEREAS, the Tohono O'odham Nation is entitled to JTPA funds to
7	develop a network of employment and training programs
8	throughout the Nation; and
9	WHEREAS, the Tohono O'odham Nation has operated a United States
10	Department of Labor Summer Youth Employment and Training
11	Program (SYETP) each year since 1974; and
12	WHEREAS, the JTPA Program has submitted an SYETP plan and budget
13	for CY 1990 in the amount of \$148,373 for review and
14	approval.
15	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
16	Council that it hereby approves the SYETP plan and budget
17	in the amount of \$148,373 for the delivery of JTPA
18	services as stated in such plan.
19	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
20	that the Tohono O'odham Nation will not fund or operate
21	the program in the interim while negotiations are still
22	being conducted and no executed grant has been awarded by
23	the United States Department of Labor.
24	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
25	that the Tohono O'odham Nation's officials, to wit: the
26	Chairman, Vice-Chairman, and any designated officials are
27	hereby authorized to negotiate and execute the grant,
28	provided, however, that any amendments affecting the
29	funding or funding levels of this grant shall be submitted
30	for further prior approval by this Council.
