WHEREAS, Section 4 of Article VIII of the Constitution of the Tohono O'Odham Nation charges the Tohono O'Odham Legislative Council the responsibility of appointing judges of the Tohono O'Odham Courts; and

WHEREAS, a vacancy exists of one full-time judge's position; and

WHEREAS, the Judiciary Committee did interview the candidates for the judges' position and recommends to the Tohono O'Odham Legislative Council that Ambrose J. Encinas be appointed to a six year term as a full-time Judge of the Tohono O'Odham Courts; and

WHEREAS, the Tohono O'Odham Legislative Council referred the candidates selection to the Districts for a thirty (30) day review period for recommendations; and

WHEREAS, the Tohono O'Odham Legislative Council Members have received input from the Districts; and

WHEREAS, the Tohono O'Odham Legislative Council is prepared to make an appointment to fill the vacancy position.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby certifies the appointment of Ambrose J. Encinas to a six year term as a full-time Judge of the Tohono O'Odham Courts.

The foregoing Resolution was passed by the Tohono O'odham Council on the 9th. day of January, 1990 at a meeting at which a quorum was present with a vote of 971.0 for; 590.0 against; 163.0 not voting; and 02 absent, pursuant to the powers vested in the Council by Section 4 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
