

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Attorney General FY-90 Budget Modification #1)

RES. NO. 116-90

1 WHEREAS, the Tohono O'odham Nation funded the office of the
2 Attorney General with Tribal funds; and

3 WHEREAS, amendments affecting the funding level or change in the
4 purpose for which the funds were budgeted are required to
5 be submitted for review and approval by the Tohono O'odham
6 Legislative Council; and

7 WHEREAS, an amendment has been submitted for review and approval.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
9 Council that it hereby approves this amendment to reduce
10 that amount by \$52,351.34, and authorize expenditures in
11 accordance with the attached budget.

12 The foregoing Resolution was passed by the Tohono O'odham Council
13 on the 6th day of April, 1990 at a meeting at which a quorum was
14 present with a vote of 1,599.0 for; -0- against; 125.0 not
15 voting; 02 absent, pursuant to the powers vested in the Council
16 by Section 1 (d)(3) of Article VI of the Constitution of the Tohono
17 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
18 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
20 16 of the Act of June 18, 1934 (48 Stat. 984).


