6	WHEREAS, the Law firm of Rothstein, Bennett, Daly, Donatelli,
7	Hughes & Glassman of Santa Fe, New Mexico were retained
8	to conduct the recruitment and screening of the potential
9	candidate for the Domestic Committees consideration; and
10	WHEREAS, the Domestic Committee, jointly with the Executive Office,
11	conducted interviews of six (6) candidates, for the
12	position of Attorney General; and
13	WHEREAS, the Domestic Committee has submitted its recommendation
14	with the nomination of Mr. David P. Frank for the Attorney
15	General; and
16	WHEREAS, the Chairman of the Nation, Mr. Angelo Joaquin, Sr., did
17	accept the recommendation of the Domestic Committee.
18 19	NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Nation is
20	hereby appointing Mr. David P. Frank as the first Attorney
21	General for the Tohono O'odham Nation.
22	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council
23	does hereby confirm the appointment of Mr. David P. Frank
24	as the Attorney General for the Tohono O'odham Nation.
25	The foregoing Resolution was passed by the Tohono O'odham Council on the 6th day of April, 1990 at a meeting at which a quorum was
26	present with a vote of 1,460.5 for; 79.0 against; 184.5 not voting; 02 absent, pursuant to the powers vested in the Council
27	by Section 2 (e) of Article VII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
28	1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
29	16 of the Act of June 18, 1934 (48 Stat. 984).
