

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Pisinemo District Six (6) Month Budget FY 1990 - AMENDMENT)

RES. NO. 118-90

1 WHEREAS, the Pisinemo District Council of the Pisinemo District did
2 on March 31, 1990, by District Resolution 1-90, approve
3 to amend their six (6) month District Budget, as passed
4 by the Tohono O'odham Legislative Council Res. No. 05-90,
5 in the amount of Forty-One Thousand Three Hundred Thirty-
6 Three Dollars and Eighty Cents (\$41,333.80); and

7 WHEREAS, the amendment would add to the Pisinemo District Six (6)
8 Month Budget, Seventeen Thousand Three Hundred Fifteen
9 Dollars and no/cents for the purchase of a 15-passenger
10 maxi van to replace one of two district vans; and

11 WHEREAS, the Pisinemo District has sufficient funds in their
12 District Account, on deposit with the Tohono O'odham
13 Accounting Department, to cover their proposed amendment;
14 and

15 WHEREAS, the Tohono O'odham Legislative Council has reviewed the
16 Pisinemo District budget and proposed amendment, which is
17 attached, and finds it in order.

18 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
19 Council that it hereby approves the Pisinemo District Six
20 (6) Month Budget Amendment request as presented in the
21 amount of Fifty-Eight Thousand Six Hundred Forty-Eight
22 Dollars and Eighty Cents (\$58,648.80) and authorizes
23 expenditures in accordance therewith.
