

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(JTPA Two (2) Year Job Training Plan (JTP) for PY 1990-1991)

RES. NO. 120-90

1 WHEREAS, the Job Training Partnership Act was enacted into law in
2 1982, replacing the Comprehensive Employment Training Act
3 (CETA); and

4 WHEREAS, funding is made available to state and tribal governments
5 to establish programs for improving the employment
6 prospects of eligible persons through the designation of
7 service delivery areas; and

8 WHEREAS, the State of Arizona is entitled to JTPA funds to develop
9 a network of employment training programs throughout the
10 State; and

11 WHEREAS, the Indian Reservations in Arizona have been designated
12 as service delivery areas and are eligible to receive
13 State JTPA funds; and

14 WHEREAS, the Tohono O'odham Nation is required to submit a Job
15 Training Plan (JTP) for PY 1990 and PY 1991 for review and
16 approval.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
18 Council that it hereby approves the two (2) year Job
19 Training Plan (JTP) for the Tohono O'odham Nation for PY
20 1990 and PY 1991 for the delivery of JTPA services on the
21 Tohono O'odham Reservation.

22 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
23 that the Tohono O'odham Nation will not fund or operate
24 the program in the interim while negotiations are still
25 being conducted and no executed contract has been awarded
26 by the Department of Economic Security.

27 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
28 that the Tohono O'odham Nation's Officials, to wit: the
29 Chairman, Vice Chairman and any designated official are
30 hereby authorized to negotiate and execute the Job
31 Training Plan, provided however, that any amendments
32 affecting the delivery of JTPA Services on the Tohono
O'odham Nation shall be submitted for further prior
approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 10th day of April, 1990 at a meeting at which a quorum was present with a vote of 1,610.0 for; -0- against; -0- not voting; 114.0 (09) absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
