


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Skill Center FY'90)

RES. NO. 129-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Tohono O'odham Skill Center Program (under a three (3)
3 year grant with the U.S. Department of Education, Office
4 of Vocational and Adult Education); and
5 WHEREAS, notification from the Department of Education has been
6 received that continuation of Federal Assistance is not
7 in the best interest of the Government; and
8 WHEREAS, the Tohono O'odham Skill Center has submitted a budget for
9 tribal assistance of \$143,519.61 to fund the program's
10 operations for the remainder of FY'90; and
11 WHEREAS, the Tohono O'odham Legislative Council is desirous to
12 continue to provide a Vocational and Education Training
13 Program to Native Americans; and
14 WHEREAS, the Tohono O'odham Skill Center has submitted a budget
15 request for Fiscal Year 1990 for review and approval by
16 the Tohono O'odham Legislative Council.
17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
18 Council that it does hereby approve the funding request
19 for the Tohono O'odham Skill Center FY'90 in order to
20 provide a Vocational Indian Education Program for Native
21 Americans.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 30th day of April, 1990 at a meeting at which a quorum was
24 present with a vote of 1,338.0 for; 106.0 against; 280.0 not
25 voting; 01 absent, pursuant to the powers vested in the Council by
26 Section 1 (d)(2)(3) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
