19	executed between Vi-ikam Doag Industries, Inc. and the
20	General Manager.
21	BE IT FURTHER RESOLVED that quarterly financial reports for the
22	Vi-ikam Doag Industries, Inc., be submitted to the Tohono
23	O'odham Nation's Accounting Department, the Commerce
24	Committee and the Tohono O'odham Legislative Council.
25	BE IT FURTHER RESOLVED that the proposed contract be amended to
26	specify that the General Manager be given 90 days to
27	evaluate and submit a report on the Vi-ikam Doag
28	Industries, Inc. to the Legislative Commerce Committee.
29	The foregoing Resolution was passed by the Tohono O'odham Council on the 30th day of April, 1990 at a meeting at which a quorum was
30	present with a vote of 897.0 for; 681.5 against; 145.5 not voting; 01 absent, pursuant to the powers vested in the Council by Section
