L. 93-638 contract with the 2 Bureau of Indian Affairs; and 3 WHEREAS, any amendments affecting the funding or funding levels of 4 the contract shall be submitted for review and approval 5 by the Tohono O'odham Legislative Council; and 6 WHEREAS, an amendment has been submitted for review and approval. 7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative 8 Council does hereby approve this amendment and requests 9 the Bureau of Indian Affairs to carry over any unexpended 10 funds from FY'89 Contract No. H50C14206317 into FY'90 11 Contract No. CTH50007090 and authorizes expenditures in 12 accordance with the attached budget. 13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council 14 that the Tohono O'odham Officials, to wit: the Chairman, 15 Vice-Chairman and any designated official are hereby 16 authorized to negotiate and execute the contract, provided 17 however, that any amendments affecting the funding or 18 funding levels of the contract shall be submitted for 19 further prior approval by this Council. 20 The foregoing Resolution was passed by the Tohono O'odham Council 21 on the 7th day of $\underline{\text{May}}$, $\underline{1990}$ at a meeting at which a quorum was present with a vote of $\underline{1,724.0}$ for; $\underline{-0}$ against; $\underline{-0}$ not voting; 22 04 absent, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'odham 23 Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 25
