
15          NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that

above indicated.


20          BE IT FURTHER RESOLVED that the Chairman and other appropriate  
21          officers of the Tohono O'Odham Nation reduce this final  
22          determination in writing regarding each of the foregoing  
23          applications for enrollment in accordance with Section 3  
24          (c) of Article III of the Enrollment Ordinance; give notice  
25          of this Council's determination in accordance with Section  
26          4 of Article III of the Enrollment Ordinance; and place the  
27          names of each applicant upon the membership roll of the  
28          Tohono O'Odham Nation in accordance with Article V of the  
29          Enrollment Ordinance.

30          The foregoing Resolution was passed by the Tohono O'Odham Council  
31          on the 8th. day of May, 1990 at a meeting at which a quorum was  
32          present with a vote of 1,724.0 for; -0- against; -0- not voting;  
and 05 absent, pursuant to the powers vested in the Council by  
Section 1 of Article II and of Section 1 (h) of Article VI of the


1 Constitution of the Tohono O'Odham Nation, adopted by the Tohono




