

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Fulfilling unexpired term of Judge's Position)

RES. NO. 145-90

1 WHEREAS, the Tohono O'Odham Legislative Council did appoint Hilda  
2 Manuel as Judge of the Tohono O'Odham Courts for a six (6)  
3 year term, beginning February 1, 1987 and ending  
4 February 1, 1993; and

5 WHEREAS, Ms. Manuel has resigned her position as a Judge of the  
6 Tohono O'Odham Courts; and

7 WHEREAS, by Resolution No. 144-90 the Tohono O'Odham Legislative  
8 Council did certify the appointment of Jess M. Cardenas  
9 as a full-time Judge of the Tohono O'Odham Courts; and

10 WHEREAS, the Tohono O'Odham Legislative Council would like to  
11 specify that Mr. Cardenas' initial term fulfill the  
12 unexpired term vacated by former Judge Manuel.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
14 Council that Jess M. Cardenas shall hereby fulfill the  
15 unexpired term vacated by former Judge Manuel, ending on  
16 February 1, 1993.


17 The foregoing Resolution was passed by the Tohono O'odham Council

19 present with a vote of 1,206.0 for; -0- against; 518.0 not  
20 voting; 05 absent, pursuant to the powers vested in the Council  
21 by Section 4 of Article VIII of the Constitution of the Tohono  
22 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
23 1986, and approved by the Acting Deputy Assistant Secretary -  
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
25 16 of the Act of June 18, 1934 (48 Stat. 984).
