

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Judges Pro Tempore of the Tohono O'odham Courts)

RES. NO. 146-90

1 WHEREAS, the Legislative Council is empowered by Article VIII,
2 Section 4 of the Constitution of the Tohono O'odham Nation
3 to appoint judges of the Tohono O'odham Courts; and
4 WHEREAS, the Legislative Council did, by Ordinance No. 01-89,
5 Chapter II, authorize the appointment of judges pro
6 tempore to the Tohono O'odham Courts upon the
7 recommendation of the Chief Judge; and
8 WHEREAS, the Chief Judge has submitted the names of attorneys
9 qualified pursuant to 2-103 of Ordinance No. 01-89 and
10 recommended their appointment as judges pro tempore of the
11 Tohono O'odham Courts; and
12 WHEREAS, Resolution No. 107-89 appointed judges pro tempore for
13 terms of two and one years; and
14 WHEREAS, three judges pro tempore terms have expired effective May
15 1, 1990; and
16 WHEREAS, the Chief Judge has submitted the names of three attorneys
17 qualified to fill the current expired terms of judge pro
18 tempore; and
19 WHEREAS, the Judiciary Committee is charged with the responsibility
20 to review the qualifications of applicants for appointment
21 as judges and to make recommendations to the Legislative
22 Council for appointments; and
23 WHEREAS, the Judiciary Committee has reviewed the qualifications
24 of the applicants submitted by the Chief Judge and finds
25 them to be qualified by temperament, education and
26 experience to be appointed as judges pro tempore of the
27 Tohono O'odham Courts, and does recommend their
28 appointments as judges pro tempore.
29 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
30 Council that it does accept the recommendations of the
31 Judiciary Committee and hereby appoints the following
32 named persons as judges pro tempore of the Tohono O'odham
