

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of SAWRSA Trust Fund Monies to Cover Travel Expenses  
for Water Projects Office and Schuk Toak District Representatives)

RES. NO. 150-90

1 WHEREAS, the Tohono O'odham Legislative Council convened in a  
2 meeting on May 9, 1990 to consider approval of the use of  
3 SAWRSA Trust Fund monies for representatives from the  
4 Water Projects Office and the Schuk Toak District to  
5 travel to Washington, D.C. to pursue the Schuk Toak Small  
6 Reclamation Loan Application; and

7 WHEREAS, this budget covers the travel costs for representatives  
8 from the Water Projects Office (Joe Antonio) and the Schuk  
9 Toak District (Herman Ramon & Harry Domingo) to travel to  
10 Washington, D.C. to meet with Congressional Agencies to  
11 pursue the Schuk Toak Small Reclamation Loan Application;


13 WHEREAS, the Tohono O'odham Legislative Council realizes that under  
14 SAWRSA, the Nation is responsible for land subjugation,  
15 and that the Small Reclamation Loan will be used for  
16 purposes of land subjugation; and

17 WHEREAS, this budget covers travel and per diem expenses for these  
18 three entities at a cost of \$2,758.50.

19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
20 Council does hereby approve the amount of \$2,758.50 from  
21 the SAWRSA Trust Fund to cover travel expenses for these  
22 delegates from the Water Projects Office and the Schuk  
23 Toak District.

24 The foregoing Resolution was passed by the Tohono O'odham Council  
25 on the 9th day of May, 1990 at a meeting at which a quorum was  
26 present with a vote of 929.5 for; 225.0 against; 569.5 not voting;  
27 06 absent, pursuant to the powers vested in the Council by Section  
28 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham  
Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
