WHEREAS, the Tohono O'odham Legislative Council realizes that under SAWRSA, the Nation is responsible for land subjugation, and that the Small Reclamation Loan will be used for purposes of land subjugation; and

WHEREAS, this budget covers travel and per diem expenses for these three entities at a cost of \$2,758.50.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the amount of \$2,758.50 from the SAWRSA Trust Fund to cover travel expenses for these delegates from the Water Projects Office and the Schuk Toak District.

The foregoing Resolution was passed by the Tohono O'odham Council on the 9th. day of May, 1990 at a meeting at which a quorum was present with a vote of 929.5 for; 225.0 against; 569.5 not voting; 06 absent, pursuant to the powers vested in the Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
