

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Water Resources Committee's Request for Extension
on Res. No. 35-90 "Authorization of a Water Recharge Investigation
on the San Xavier District Utilizing C.A.P. Waters")

RES. NO. 151-90

1 WHEREAS, upon adoption of Tohono O'odham Legislative Council
2 Resolution No. 35-90, "Authorization of a Water Recharge
3 Investigation on the San Xavier District Utilizing C.A.P.
4 Waters;" and

5 WHEREAS, said resolution requested that the Water Resources
6 Committee perform the following four (4) recommendations:

- 7 (1) Explore the technical feasibility of a recharge
8 program, either alone or in concert with the City
9 of Tucson, in lieu of allocating those waters for
10 delivery to the 9B new farm.
- 11 (2) Identify new provisions of law needed in Congress,
12 in the Legislative Council, and in the Arizona
13 Legislature to implement a water recharge program,
14 consistent with principles, benefits, and
15 obligations of the 1982 Settlement Act.
- 16 (3) Request the assistance of the Bureau of
17 Reclamation and other interested parties to
18 undertake a thorough assessment of a recharge
19 program, while insuring that the federal
20 obligation to construct a new water project at the
21 San Xavier District is not waived.
- 22 (4) Recommend actions to the Legislative Council
23 needed to implement a recharge program for the San
24 Xavier District using 9B water, if such a program
25 proves desirable; and

18 WHEREAS, the Water Resources Committee did bring on a consultant
19 to initiate and pursue the study tasks needed, to explore
20 the technical feasibility of a recharge program, in lieu
21 of allocating the waters for delivery to the 9B new farm
22 as authorized in recommendation No. 1; and

23 WHEREAS, the consultant did make presentations to the Water
24 Resources Committee and the San Xavier District; and

25 WHEREAS, additional time is needed by the consultant to summarize
26 and finalize data which is still being received; and

27 WHEREAS, the Water Resources Committee is recommending an extension
28 of two (2) months to make its final recommendation, and
29 that said recommendation will be brought forth as soon as
30 possible within that two (2) month period.

31 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
32 Council that it does hereby approve the Water Resources





The foregoing Resolution was passed by the Tohono O'odham Council on the 10th day of May, 1990 at a meeting at which a quorum was present with a vote of 1,281.0 for; -0- against; 285.0 not voting; 158.0 (06) absent, pursuant to the powers vested in the Council by Section 1 (a) & (c)(i)(2) of Article VI and Section 2 (a) & (d) of Article XVII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




