

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1991 Parenting Skills Training  
Budget Modification)

RES. NO. 157-90

1 WHEREAS, the Tohono O'Odham Social Services Department has the  
2 primary responsibility to provide protection and  
3 intervention services to families at risk for child abuse  
4 and neglect; and  
5 WHEREAS, a proposal was submitted to the Arizona Department of  
6 Economic Security for FY 1991 Parenting Skills Training  
7 funds; and  
8 WHEREAS, negotiations were held with the Department of Economic  
9 Security Office, and the Nation was informed of a  
10 reduction in the amount of \$10,000.00; and  
11 WHEREAS, any amendments affecting the funding or funding levels of  
12 the contract shall be submitted for review and approval  
13 by the Tohono O'Odham Legislative Council; and  
14 WHEREAS, an amendment has been submitted for review and approval.  
15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative  
16 Council does hereby approve this amendment to the contract  
17 and authorizes expenditures in accordance with the  
18 attached budget.  
19 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
20 that the Tohono O'Odham Nation's officials, to wit: the  
21 Chairman, Vice Chairman and any designated official are  
22 hereby authorized to negotiate and execute the contract,  
23 provided however, that any amendments affecting the  
24 funding or funding levels of the contract shall be  
25 submitted for further prior approval by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Council  
27 on the 11th. day of May, 1990 at a meeting at which a quorum was  
28 present with a vote of 1,599.0 for; -0- against; -0- not voting;  
29 125.0 absent, pursuant to the powers vested in the Council by  
30 Section 1 (f) of Article VI of the Constitution of the Tohono  
31 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
32 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
