The foregoing Resolution was passed by the Tohono O'odham Council on the 11th day of May, 1990 at a meeting at which a quorum was present with a vote of 913.0 for; 250.0 against; 436.0 not voting; 125.0 (08) absent, pursuant to the powers vested in the Council by Section 1 (c)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
