

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Supporting Tohono O'odham Education Committee/  
Board of Directors Res. No. 12-90

RES. NO. 158-90

1 WHEREAS, the Tohono O'odham Education Committee/Board of Directors  
2 is seeking Council's support of Res. No. 12-90 "Special  
3 Audit Request;" and

4 WHEREAS, the Tohono O'odham Legislative Council has been informed  
5 of the situation regarding the Tohono O'odham Skill  
6 Center, as well as problems previously experienced by the  
7 Tohono O'odham Education Department and the Education  
8 Committee at various levels in the financial area; and

9 WHEREAS, said Resolution No. 12-90 "Special Audit Request"  
10 specifically requests that the following recommendations  
11 receive immediate action:

- 12 1) An audit be conducted on the Nation's Accounting  
13 Department within thirty (30) days.
- 14 2) Copies of the audit, upon completion, be made  
15 available to the eleven (11) Districts.
- 16 3) The vacancy of the Nation's Treasurer be filled  
17 within thirty (30) days.
- 18 4) Restructure/Improve the Financial Management  
19 system to provide a better quality service to  
20 meet the needs of the Nation's District,  
21 Departments, and/or Programs; and

22 WHEREAS, the Legislative Council is in support of the concerns of  
23 the Education Department and the Education Committee as  
24 outlined in Resolution No. 12-90.

25 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
26 Council hereby supports the Education Committee/Board of  
27 Directors Res. No. 12-90.

28 The foregoing Resolution was passed by the Tohono O'odham Council  
29 on the 11th day of May, 1990 at a meeting at which a quorum was  
30 present with a vote of 913.0 for; 250.0 against; 436.0 not voting;  
31 125.0 (08) absent, pursuant to the powers vested in the Council by  
32 Section 1 (c)(2) of Article VI of the Constitution of the Tohono  
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
