2	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
3	Legislative Council does hereby approve the amendment to
4	the JTPA Program.
5	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
6	that the Tohono O'odham Nation's Officials, to wit: the
7	Chairman, Vice Chairman and any designated official are
8	hereby authorized to negotiate and execute the grant,
9	provided, however, that any amendments affecting the
20	funding or funding levels of this grant shall be
21	submitted for further prior approval by this Council.
22	The foregoing Resolution was passed by the Tohono O'odham Council on the 10th. day of January, 1990 at a meeting at which a
23	quorum was present with a vote of <u>1,518.0</u> for; <u>-0-</u> against; <u>79.0</u> not voting; and <u>127.0</u> absent, pursuant to the powers
24	vested in the Council by Section <u>1 (f)</u> of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
25	O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March
26	6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
