RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Override of Vetoed Res. No. <u>144-90</u>, "Certifying the Appointment of Jess M. Cardenas as Judge of the Tohono O'odham Courts")

RES. NO. 162-90

1 WHEREAS, the Tohono O'odham Legislative Council did by Resolution 2 No. 144-90 approve for certifying the appointment of Jess 3 M. Cardenas as Judge of the Tohono O'odham Courts; and 4 WHEREAS, upon presentation of Resolution No. 144-90 to the Chairman 5 of the Tohono O'odham Nation, he did disapprove thereof 6 and returned it to the Council with his objections in 7 accordance with the provisions of Article VII, Section 5 8 of the Constitution of the Tohono O'odham Nation; and 9 WHEREAS, the Tohono O'odham Legislative Council has reviewed the 10 Chairman's objections and after consideration, again voted 11 to pass Resolution No. 144-90. 12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative 13

NOW, THEREFORE, BE IT RESOLVED that the Tonono O'odnam Legislative
Council does hereby override the Chairman's veto of
Resolution No. 144-90, "Certifying the Appointment of Jess
M. Cardenas as Judge of the Tohono O'odnam Courts," by a
vote of two-thirds (2/3) of the votes cast; 1,114.0.

The foregoing Resolution was presented to the Tohono O'odham Council on the  $\underline{4th}$  day of  $\underline{June}$ ,  $\underline{1990}$  at a meeting at which a quorum was present with a vote of  $\underline{-0-}$  for;  $\underline{1,670.5}$  against;  $\underline{53.5}$  not voting;  $\underline{01}$  absent, failed to pass because it did not receive a majority of the votes cast as required by Section  $\underline{2}$  of Article V of the Constitution of the Tohono O'odham Nation.
