S.X. District Utilizing C.A.P. Waters")

2 WHEREAS, the Tohono O'odham Legislative Council did approve  
3 Resolution No. 151-90, "Approving Water Resources  
4 Committee's Request for Extension on Res. No. 35-90,  
5 "Authorization of a Water Recharge Investigation on the  
6 S.X. District Utilizing C.A.P. Waters;" and

7 WHEREAS, upon presentation of Resolution No. 151-90 to the Chairman  
8 of the Tohono O'odham Nation, he did disapprove thereof  
9 and returned it to the Council with his objections in  
10 accordance with the provisions of Article VII, Section 5  
11 of the Constitution of the Tohono O'odham Nation; and

12 WHEREAS, the Tohono O'odham Legislative Council has reviewed the  
13 Chairman's objections and after consideration, again voted  
14 to pass Resolution No. 151-90.


15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
16 Council does hereby override the Chairman's veto of  
17 Resolution No. 151-90, "Approving the Water Resources  
18 Committee's Request for Extension on Res. No. 35-90,  
19 "Authorization of a Water Recharge Investigation on the  
20 San Xavier District Utilizing C.A.P. Waters," by a vote  
21 of two-thirds (2/3) of the votes cast; 1,031.6.

22 The foregoing Resolution was presented to the Tohono O'odham  
23 Council on the 4th day of June, 1990 at a meeting at which a quorum  
24 was present with a vote of 700.0 for; 847.5 against; 176.5 not  
25 voting; 01 absent, failed to pass because it did not receive a  
majority of the votes cast as required by Section 2 of Article V  
of the Constitution of the Tohono O'odham Nation.
