WHEREAS, the Tohono O'odham Legislative Council did approve Resolution No. <u>151-90</u>, "Approving Water Resources Committee's Request for Extension on Res. No. 35-90, "Authorization of a Water Recharge Investigation on the

S.X. District Utilizing C.A.P. Waters;" and

whereas, upon presentation of Resolution No. 151-90 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Nation; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the Chairman's objections and after consideration, again voted to pass Resolution No. 151-90.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby override the Chairman's veto of Resolution No. 151-90, "Approving the Water Resources Committee's Request for Extension on Res. No. 35-90, "Authorization of a Water Recharge Investigation on the San Xavier District Utilizing C.A.P. Waters," by a vote of two-thirds (2/3) of the votes cast; 1,031.6.

The foregoing Resolution was presented to the Tohono O'odham Council on the 4th day of 5June, 1990 at a meeting at which a quorum was present with a vote of 5June, 1990 for; 1990 against; 1990 not voting; 1990 absent, failed to pass because it did not receive a majority of the votes cast as required by Section 1990 Article V of the Constitution of the Tohono O'odham Nation.
