

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Enrollment - June)

1 WHEREAS, the Tohono O'Odham Council has reviewed the

6 the above named applicants are eligible for enrollment as
7 members of the Tohono O'Odham Nation under Section 1(a)
8 or (b) of Article II of the Constitution of the Tohono
9 O'Odham Nation, and that their applications are approved,
10 as herein above indicated.

11 BE IT FURTHER RESOLVED that the Chairman and other appropriate
12 officers of the Tohono O'Odham Nation reduce this final
13 determination in writing regarding each of the foregoing
14 applications for enrollment in accordance with Section 3
15 (c) of Article III of the Enrollment Ordinance; give
16 notice of this Council's determination in accordance with
17 Section 4 of Article III of the Enrollment Ordinance; and
18 place the names of each applicant upon the membership roll
19 of the Tohono O'Odham Nation in accordance with Article
20 V of the Enrollment Ordinance.


21 The foregoing Resolution was passed by the Tohono O'Odham Council
22 on the 4th day of June, 1990 at a meeting at which a quorum was
23 present with a vote of 1,480.5 for; 63.5 against; 180.0 not
24 voting; and 01 absent, pursuant to the powers vested in the Council
by Section 1 of Article II and of Section 1 (h) of Article VI of
the Constitution of the Tohono O'Odham Nation, adopted by the
Tohono O'Odham Nation on January 18, 1986 and approved by the
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
March 6, 1986 pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984).






