
1 WHEREAS, the following named person(s) have formally relinquished

9 membership roll.


10 The foregoing resolution was passed by the Tohono O'odham Council

12 present with a vote of 1,194.5 for; 472.5 against; 57.0 not
13 voting; and 01 absent; pursuant to the powers vested in the
14 Council by Section 3 of Article II and Article VI Section 1 (h) of
the Constitution of the Tohono O'odham Nation on January 18, 1986,
and approved by the Acting Deputy Assistant Secretary -Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
