

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tribal-State Compact Negotiating Team FY '90 Budget)

RES. NO. 176-90

1 WHEREAS, the Tohono O'Odham Legislative Council enacted Resolution
2 No. 260-89 which established the Negotiating Committee
3 for the purpose of negotiating a Tribal-State Compact with
4 the State of Arizona for the operation of gaming
5 activities; and

6 WHEREAS, the Committee has found it necessary to be involved with
7 the National Indian Gaming Association (NIGA) in the
8 formulation of the proposed regulations for Indian Gaming;
9 and

10 WHEREAS, the Tohono O'Odham Nation has appointed a Tribal-State
11 Compact Negotiating Team to ensure continued operations
12 of Papago Bingo; and

13 WHEREAS, the Tribal State Compact Negotiating Team has submitted
14 a proposed budget in the amount of \$10,000.00 to attend
15 National Indian Gaming Conferences that will be beneficial
16 to the Tohono O'Odham Nation's bingo activities, and the
17 negotiations of the compact.

18 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
19 Council that it hereby approves the Tribal-State Compact
20 Negotiating Team FY '90 Budget.

21 The foregoing Resolution was passed by the Tohono O'odham Council
22 on the 5th day of June, 1990 at a meeting at which a quorum was
23 present with a vote of 1,667.0 for; 57.0 against; -0- not
24 voting; 01 absent, pursuant to the powers vested in the Council
25 by Section 1 (d)(3) of Article VI of the Constitution of the
26 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
27 January 18, 1986, and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
29 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
