


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(JTPA PY '1990)


1 WHEREAS, the Job Training Partnership Act was enacted into law in
2 1982 replacing the Comprehensive Employment Training Act
3 (CETA); and
4 WHEREAS, funding is made available to State and Tribal Governments
5 to establish programs for improving the employment
6 prospects of eligible persons through the designation of
7 service delivery areas; and
8 WHEREAS, the State of Arizona is entitled to JTPA funds to develop
9 a network of employment training programs throughout the
10 State; and
11 WHEREAS, the Indian Reservations in Arizona have been designated
12 as service delivery areas and are eligible to receive
13 State JTPA funds; and
14 WHEREAS, the JTPA Program has submitted for review and approval of
15 the budget for Title II-A Programs in the amount of
16 \$327,847.00 for PY 1990.
17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
18 Council that it hereby approves the attached budget in the
19 amount of \$327,847.00.
20 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
21 that the Tohono O'odham Nation will not fund or operate
22 the program in the interim while negotiations are still
23 being conducted and no executed contract has been awarded
24 by the Department of Economic Security.
25 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
26 that the Tohono O'odham Nation's Officials, to wit: the
27 Chairman, Vice Chairman and any designated official are
28 hereby authorized to negotiate and execute the contract,
29 provided, however, that any amendments affecting the
30 funding or funding levels of this contract shall be
31 submitted for further prior approval by this Council.

1 The foregoing Resolution was passed by the Tohono O'odham Council
2 on the 5th day of June, 1990 at a meeting at which a quorum was
3 present with a vote of 1724.0 for; -0- against; -0- not voting;
4 -0- absent, pursuant to the powers vested in the Council by
5 Section 1 (f) of Article VI of the Constitution of the Tohono
6 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
7 1986, and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
9 16 of the Act of June 18, 1934 (48 Stat. 984).






