

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(JTPA Title II-B Budget Amendment
TSDA/DES Contracts)

RES. NO. 181-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the JTPA
2 Title II-B under the CY 1990 Contract with the State of
3 Arizona; and

4 WHEREAS, any amendments affecting the funding or funding levels of
5 the contract shall be submitted for review and approval
6 by the JTPA Title II-B Program; and

7 WHEREAS, an amendment has been submitted for review and approval
8 by the JTPA Title II-B Program; and

9 WHEREAS, the original plan budget was \$108,039.00 with the variance
10 of \$89,162.00 making a final total budget of \$197,201.00.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
12 Council that it hereby approves the amendment to the JTPA
13 Title II-B Program.

14 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
15 that the Tohono O'odham Nation's Officials, to wit: the
16 Chairman, Vice Chairman and any designated official are
17 hereby authorized to negotiate and execute the contract,
18 provided, however, that any amendments affecting the
19 funding or funding levels of this contract shall be
20 submitted for further prior approval by this Council.


21 The foregoing Resolution was passed by the Tohono O'odham Council
22 on the 5th day of June, 1990 at a meeting at which a quorum was
23 present with a vote of 1724.0 for; -0- against; -0- not voting;
24 -0- absent, pursuant to the powers vested in the Council by
25 Section 1 (f) of Article VI of the Constitution of the Tohono
26 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
27 1986, and approved by the Acting Deputy Assistant Secretary -
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
29 16 of the Act of June 18, 1934 (48 Stat. 984).
