

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham WIC Program
Budget Modification)

RES. NO. 182-90

1 WHEREAS, the Tohono O'odham Nation is currently providing
2 preventive health care for women, infants and children
3 during the Fiscal Year 1990; and

4 WHEREAS, the Inter-Tribal Council of Arizona has received
5 supplemental feeding funds from the United States
6 Department of Agriculture for programs designed to benefit
7 women, infants and children; and

8 WHEREAS, an amendment to the FY 1990 WIC Memorandum of
9 Understanding does hereby reflect an increase to our FY
10 1990 funding level; and

11 WHEREAS, any amendments affecting the funding or funding levels of
12 the contract shall be submitted for review and approval
13 by the Tohono O'odham Legislative Council; and

14 WHEREAS, an amendment has been submitted for review and approval
15 by the Tohono O'odham Women, Infant and Children Program.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
17 Council does hereby approve the amendment to the Women,
18 Infant and Children Memorandum of Understanding and
19 authorize expenditures in accordance with the attached
20 budget.

21 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
22 that the Tohono O'odham Nation's Officials, to wit: the
23 Chairman, Vice Chairman and any designated official are
24 hereby authorized to negotiate and execute the contract,
25 provided however, that any amendments affecting the
26 funding or funding levels of the contract shall be
27 submitted for further prior approval by this Council.

28 The foregoing Resolution was passed by the Tohono O'odham Council
29 on the 5th day of June, 1990 at a meeting at which a quorum was
30 present with a vote of 1,667.0 for; -0- against; 57.0 not
31 voting; 0 absent, pursuant to the powers vested in the Council by
32 Section 1 (f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
