15	by the Higher Education Program.								
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative

26	submitted for further prior approval by this Council.

O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section

16 of the Act of June 18, 1934 (48 Stat. 984).
