

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1990 Title XX-Child Day Care
Budget Modification #1)

RES. NO. 191-90

1 WHEREAS, the Tohono O'odham Nation has consistently supported the
2 nurturance of its young members by providing for their
3 welfare through various programs and services designed to
4 meet their special needs; and

5 WHEREAS, the Child Day Care Services Program has been successfully
6 operated through the Early Childhood Division and has
7 served many young Tohono O'odham children; and

8 WHEREAS, the Tohono O'odham Child Day Care Services Program has
9 received additional funds in the amount of \$2,470.00; and

10 WHEREAS, any amendments affecting the funding or funding levels of
11 the contract shall be submitted for review and approval
12 by the Tohono O'odham Legislative Council; and

13 WHEREAS, an amendment has been submitted for review and approval
14 by the Child Day Care Services Program.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
16 Council does hereby approve the amendment of the Title XX
17 Child Day Care Services and authorize expenditures in
18 accordance with the attached budget.

19 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
20 that the Tohono O'odham Nation's Officials, to wit: the
21 Chairman, Vice Chairman and any designated official are
22 hereby authorized to negotiate and execute the contract,
23 provided however, that any amendments affecting the
24 funding or funding levels of the contract shall be
25 submitted for further prior approval by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Council
27 on the 6th day of June, 1990 at a meeting at which a quorum was
28 present with a vote of 1,724.0 for; -0- against; -0- not voting;
29 02 absent, pursuant to the powers vested in the Council by Section
30 1 (f) of Article VI of the Constitution of the Tohono O'odham
31 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
32 and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
