

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(San Xavier Rehabilitation Pre-Design Contract No. 8-CS-30-04830
Budget Modification #13)

RES. NO. 194-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 San Xavier Rehabilitation Pre-Design Contract under P. L.
3 93-638 with the Bureau of Reclamation; and
4 WHEREAS, any amendments affecting the funding or funding levels of
5 the contract shall be submitted for review and approval
6 by the Tohono O'odham Legislative Council; and
7 WHEREAS, an amendment has been submitted by the Tohono O'odham
8 Nation's Central Arizona Project for review and approval.
9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
10 Council does hereby approve the amendment to the San
11 Xavier Rehabilitation Pre-Design Contract.

12 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
13 that the Tohono O'odham Nation's Officials, to wit: the
14 Chairman, Vice Chairman and any designated official are
15 hereby authorized to negotiate and execute the contract,
16 provided however, that any amendments affecting the
17 funding or funding levels of the contract shall be
18 submitted for further prior approval by this Council.

19 The foregoing Resolution was passed by the Tohono O'odham Council
20 on the 7th day of June, 1990 at a meeting at which a quorum was
21 present with a vote of 1,667.0 for; -0- against; 57.0 not
22 voting; 0 absent, pursuant to the powers vested in the Council by
23 Section 1 (f) of Article VI of the Constitution of the Tohono
24 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
25 1986, and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
27 16 of the Act of June 18, 1934 (48 Stat. 984).





submittal.


