

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Proceed in Closed Session to Discuss Water Resources
Committee Recommendations)

LEGISLATIVE ORDER NO. 204-90

1 WHEREAS, on July 5, 1990 the Tohono O'odham Legislative Council
2 held a Special Council Meeting pursuant to Resolution No.
3 197-90, "Extending the Water Recharge Study authorized
4 under 35-90"; and
5 WHEREAS, the purpose of this meeting was to review the final
6 recommendations of the Water Resources Committee regarding
7 a water recharge program utilizing CAP water by the San
8 Xavier District; and
9 WHEREAS, the Water Resources Committee also investigated possible
10 amendments to the Southern Arizona Water Rights Settlement
11 Act (SAWRSA); and
12 WHEREAS, prior to the discussion in the above-matter, David Frank,
13 Attorney General for the Nation did discuss with the
14 Legislative Council attorney-client privileged information
15 and the confidentiality of such information; and
16 WHEREAS, the Attorney General cautioned that any discussion during
17 an "open public meeting" may be construed to be a waiver
18 of attorney-client confidentiality; and
19 WHEREAS, the Attorney General advised that in some instances the
20 Tohono O'odham Legislative Council would need to consider
21 proceeding in closed session in order to prevent the
22 disclosure of information and/or strategy that may be used
23 against the Nation in a detrimental manner; and
24 WHEREAS, the Attorney General advised the Council that it would be
25 in the best interest of the Nation to review the final
26 recommendations of the Water Resources Committee regarding
27 a water recharge program utilizing CAP water by the San
28 Xavier District in closed session.
29 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative
30 Council that it hereby closes its session to review the
31 final recommendaton of the Water Resources Committee
32 pursuant to Resolution No. 197-89.


1 BE IT FURTHER ORDERED that the Nation's Officials, the allottees,
2 the Attorney General, and the Water Resources Consultant
3 be allowed to remain in this session.

4 The foregoing Order was passed by the Tohono O'odham Council on
5 the 5th day of July, 1990 at a meeting at which a quorum was
6 present with a vote of 1,121.0 for; 293.0 against; -0- not voting;
7 310.0 (04) absent, pursuant to the powers vested in the Council by
8 Section 1 (a) of Article VI of the Constitution of the Tohono
9 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
10 1986, and approved by the Acting Deputy Assistant Secretary -
11 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
12 16 of the Act of June 18, 1934 (48 Stat. 984).
