

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Water Resource Committee Recommendation to Request a 3-month  
Extension on the San Xavier Water Recharge Feasibility Study)

RES. NO. 206-90

1 WHEREAS, the Water Resource Committee is the oversight committee on  
2 all water related issues on the Tohono O'odham Nation;  
3 and

4 WHEREAS, Resolution No. 197-90 authorized the Recharge Feasibility  
5 Study to be extended to June 30, 1990 and that the final  
6 recommendation of the Water Resource Committee be  
7 presented to the Legislative Council on July 5, 1990; and

8 WHEREAS, the recommendation of the Water Resource Committee is to  
9 request for a three (3) month extension to complete the  
10 following tasks:

- 11 A. Meet with Allottees on proposed litigation.
- 12 B. Define the impacts of rescinding Plan 9B.
- 13 C. Identify the tribal costs for the development of a  
14 pilot recharge project.
- 15 D. Review other alternatives i.e., Avra Valley, water  
16 transfers, water leasing.
- 17 E. Consult with hydrological experts on water resource  
18 inventory.

19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
20 Council hereby approves the recommendation of the Water  
21 Resource Committee.

22 BE IT FURTHER RESOLVED that the Water Resource Committee and the  
23 Budget and Finance Committee review and develop a budget  
24 for the three (3) month extension.

25 BE IT FINALLY RESOLVED, that the Water Resource Committee will  
26 present their final recommendation at the end of October,  
27 1990.

28 The foregoing Resolution was passed by the Tohono O'odham Council  
29 on the 5th day of July, 1990 at a meeting at which a quorum was  
30 present with a vote of 859.0 for; 516.0 against; 349.0 not  
31 voting; 03 absent, pursuant to the powers vested in the Council  
32 by Section 1 (a), (c), & (i)(2) of Article VI of the Constitution  
of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
