3	additional 16% of salaries and wages for all programs; and

5	Care Program to satisfy this mandate is \$14,614.00; and
6	WHEREAS, the Title XX Day Care Program performed a budget analysis
7	and determined budgeting for the additional 16% would have
8	an unacceptable negative impact in delivery of day care
9	services by the program; and
10	WHEREAS, the Title XX Day Care Program hereby requests \$14,614.00
11	to supplement the program budget to meet the costs of
12	increased fringe benefits.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
14	Council does hereby approve the Supplemental request and
15	authorize expenditures in accordance with the attached
16	budget.
