(Tohono O'Odham Enrollment Program FY-90  
Budget Modification #1)

RES. NO. 217-90

1 WHEREAS, the Tohono O'Odham Nation is currently operating the  
2 Enrollment Program with tribal funds; and  
3 WHEREAS, amendments affecting the funding level or changes in the  
4 purpose for which the funds were budgeted are required to  
5 be submitted for review and approval by the Tohono O'odham  
6 Legislative Council; and  
7 WHEREAS, amendment has been submitted for review and approval.  
8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
9 Council that it hereby approves this amendment  
10 transferring funds between line items and authorize  
11 expenditures in accordance with the attached budget.

12 The foregoing Resolution was passed by the Tohono O'odham Council  
13 on the 10th day of July, 1990 at a meeting at which a quorum was  
14 present with a vote of 1,724.0 for; -0- against; -0- not voting;  
15 05 absent, pursuant to the powers vested in the Council by Section  
16 1 (d)(3) of Article VI of the Constitution of the Tohono O'odham  
Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).




