The foregoing resolution was presented to the Tohono O'Odham Legislative Council on the 5th. day of February , 1990 , at a meeting at which a quorum was present and, by a vote of 1,216.0 for; 445.5 against; 62.5 not voting; and 01 absent, was passed by a majority of at least two-thirds (2/3) 1,108.0 of the votes cast and became law as provided in Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.
