

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override Veto of Res. No.s 13-90, 14-90
and 15-90)

RES. NO. 21-90

1 WHEREAS, the Tohono O'Odham Legislative Council did by Res. No.
2 13-90 approve the JTPA/SDA Title II-B Summer Youth
3 Employment & Training Program for Calendar Year 1990,
4 and by Res. No. 14-90 did approve the JTPA Title II-A
5 Budget Amendment and by Res. No. 15-90 did approve the
6 JTPA DOL Grant #99-7-0181-55-083-02; and

7 WHEREAS, upon presentation of Res. No.'s 13-90, 14-90 and 15-90
8 to the Chairman of the Tohono O'Odham Nation he did
9 disapprove thereof and returning it to the Council with
10 his objections in accordance with the provisions of
11 Article VII, Section 5 of the Constitution of the Tohono
12 O'Odham Nation; and

13 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
14 Chairman's objections and after consideration again
15 voted to pass Res. No.'s 13-90, 14-90 and 15-90.


16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
17 Legislative Council does hereby override the Chairman's
18 veto of Res. No.'s 13-90, 14-90 and 15-90, by a vote of
19 two-thirds (2/3) of the votes cast 1,108.0

21 The foregoing resolution was presented to the Tohono O'Odham
22 Legislative Council on the 5th. day of February, 1990, at a
23 meeting at which a quorum was present and, by a vote of 1,216.0
24 for; 445.5 against; 62.5 not voting; and 01 absent, was
passed by a majority of at least two-thirds (2/3) 1,108.0 of the
votes cast and became law as provided in Section 5 of Article VII
of the Constitution of the Tohono O'Odham Nation.
