WHEREAS, the Accounting Department is having a difficult time allocating the cost of long distance charges incurred by the different departments/programs run by the Nation; and WHEREAS, a hardware/software package is available to enhance the existing AT&T equipment to provide the Nation with a precise and accurate method of assessing the cost of long distance calls by the departments making the call and not by the number of extension.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the budget request in the amount of \$5,263.39 to enhance the existing phone systems to assess the cost of long distance calls.

The foregoing Resolution was passed by the Tohono O'odham Council on the 10th. day of July, 1990 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; 05 absent, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Said Resolution was submitted for approval to the office of the Chairman of the Tohono O'odham Nation on the day of day of 1990, at 2:38 o'clock, M., pursuant to the provisions of Section 5 of Article VII of the Constitution and will become effective upon his approval or upon his failure to either approve or disapprove it within 48 hours of submittal.
