

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Administrative Provisions FY 90 - Budget Modification #2
Telephone System Request)

RES. NO. 222-90

1 WHEREAS, the Accounting Department is having a difficult time
2 allocating the cost of long distance charges incurred by
3 the different departments/programs run by the Nation; and

4 WHEREAS, a hardware/software package is available to enhance the
5 existing AT&T equipment to provide the Nation with a
6 precise and accurate method of assessing the cost of long
7 distance calls by the departments making the call and not
8 by the number of extension.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
10 Council that it hereby approves the budget request in the
11 amount of \$5,263.39 to enhance the existing phone systems
12 to assess the cost of long distance calls.

13 The foregoing Resolution was passed by the Tohono O'odham Council
14 on the 10th. day of July, 1990 at a meeting at which a quorum was
15 present with a vote of 1,724.0 for; -0- against; -0- not voting;
16 05 absent, pursuant to the powers vested in the Council by Section
17 1 (d)(3) of Article VI of the Constitution of the Tohono O'odham
18 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
19 and approved by the Acting Deputy Assistant Secretary - Indian
20 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
21 the Act of June 18, 1934 (48 Stat. 984).
