5	Program to satisfy this mandate is \$3,497.00; and					
6	WHEREAS, the Higher Education Program performed a budget analysis					
7	and determined budgeting for the additional 16% would have					
8	an unacceptable negative impact in delivery of services					
9	by the program; and					
10	WHEREAS, the Higher Education Program hereby requests \$3,497.00 to					
11	supplement the program budget to meet the costs of					
12	increased fringe benefits.					
13	THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the Supplemental request and					
14	Council does hereby approve the Supplemental request and					
15	authorize expenditures in accordance with the attached					
16	budget.
