

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham FY 1991 Skill Center Contract Extension)

RES. NO. 228-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the Skill
2 Center under FY 1990 P. L. 93-638 contract with the Bureau
3 of Indian Affairs; and

4 WHEREAS, such tribal operations have been successful and beneficial
5 to the Tohono O'odham Nation and its people; and

6 WHEREAS, the Tohono O'odham Nation does desire to extend the
7 contract for provision of services during FY 1991; and

8 WHEREAS, the Tohono O'odham Legislative Council has reviewed and
9 approved the FY 1991 Skill Center contract extension and
10 budget.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
12 Council that it does authorize and request the Bureau of
13 Indian Affairs to extend Contract No. CTH50007090 with the
14 Tohono O'odham Nation under P. L. 93-638 regulations and
15 procedures for the provision of services titled: Skill
16 Center.

17 BE IT FURTHER RESOLVED that the duration of this contract extension
18 will commence on October 01, 1990 through September 30,
19 1991.

20 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
21 that the Tohono O'odham Nation will not fund or operate
22 the program in the interim while negotiations are still
23 being conducted and no executed contract extension has
24 been approved by the Bureau of Indian Affairs.

25 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
26 that the Tohono O'odham Nation's Officials, to wit: the
27 Chairman, Vice Chairman and any designated official are
28 hereby authorized to negotiate and execute the contract,
29 provided however, that any amendments affecting the
30 funding or funding levels of the contract shall be
31 submitted for further prior approval by this Council.

1 The foregoing Resolution was passed by the Tohono O'odham Council
2 on the 10th day of July, 1990 at a meeting at which a quorum was
3 present with a vote of 1,618.0 for; 106.0 against; -0- not
4 voting; 05 absent, pursuant to the powers vested in the Council
5 by Section 1 (f) of Article VI of the Constitution of the Tohono
6 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
7 1986, and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
9 16 of the Act of June 18, 1934 (48 Stat. 984).
