8	for non-commissioned personnel in the amount of \$40,983.00							
9	and 9% fringe benefits for commissioned personnel in the							
10	amount of \$78,289.00; and							
11	WHEREAS, the Law Enforcement and Detention Services Program							
12	performed a budget analysis and determined budgeting for							
13	the additional 16% would have an unacceptable negative							
14	impact in delivery of services by the program; and							
15	WHEREAS, the Law Enforcement and Detention Services Program hereby							
16	requests \$119,272.00 to supplement the program budget to							
17	meet the costs of increased fringe benefits.

20	authorize expenditures in accordance with the attached							
21	budget.
