14	supplemental grant and authorizes expenditures in
15	accordance with the attached budget.
16	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
17	that the Tohono O'odham Nation's Officials, to wit: The
18	Chairman, Vice Chairman and any designated official are
19	hereby authorized to negotiate and execute the grant,
20	provided however, that any amendments affecting the
21	funding or funding levels of this grant shall be submitted
22	for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 11th day of July, 1990 at a meeting at which a quorum was present with a vote of 1,660.5 for; 63.5 against; -0- not voting; 03 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
