

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'odham Head Start Program Supplemental Grant)

RES. NO. 234-90

1 WHEREAS, the Tohono O'odham Nation has operated a Head Start  
2 Program to provide and serve educational and pre-school  
3 learning experiences for children between ages of 3-5  
4 years; and

5 WHEREAS, the Department of Health and Human Services,  
6 Administration for Children, Youth and Families has  
7 provided funding for supplemental grants for the Head  
8 Start Program; and


9 WHEREAS, the Head Start Program has prepared a proposal for the  
10 supplemental funds for program improvement to be submitted  
11 to the Department of Health and Human Services.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
13 Council has reviewed and approved the Head Start  
14 supplemental grant and authorizes expenditures in  
15 accordance with the attached budget.

16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
17 that the Tohono O'odham Nation's Officials, to wit: The  
18 Chairman, Vice Chairman and any designated official are  
19 hereby authorized to negotiate and execute the grant,  
20 provided however, that any amendments affecting the  
21 funding or funding levels of this grant shall be submitted  
22 for further prior approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Council  
24 on the 11th day of July, 1990 at a meeting at which a quorum was  
25 present with a vote of 1,660.5 for; 63.5 against; -0- not  
26 voting; 03 absent, pursuant to the powers vested in the Council  
27 by Section 1 (f) of Article VI of the Constitution of the Tohono  
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
