

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'odham FY 1991 Management of Health Services)

RES. NO. 236-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the  
2 Management of Health Services Program under FY 1990 P. L.  
3 93-638 contracts with the Public Health, Indian Health  
4 Services; and

5 WHEREAS, such tribal operations have been successful and beneficial  
6 to the Tohono O'odham Nation and its people; and

7 WHEREAS, 25 CFR Sec. 371.20 requires that all proposals to  
8 recontract under P. L. 93-638 be submitted to the Tohono  
9 O'odham Legislative Council for review and approval at  
10 least 120 days prior to the contract termination; and

11 WHEREAS, the Tohono O'odham Nation does desire to recontract for  
12 provision of services during FY 1991; and

13 WHEREAS, the Tohono O'odham Legislative Council has reviewed and  
14 approved the Management of Health Services Program FY 1991  
15 recontract application and budget.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
17 Council that it does authorize and request the Public  
18 Health, Indian Health Service to contract with the Tohono  
19 O'odham Nation under P. L. 93-638 regulations and  
20 procedures for the provision of services titled:  
21 Management of Health Services.

22 BE IT FURTHER RESOLVED that the duration of this contract shall  
23 commence on October 01, 1990 through September 30, 1991.

24 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
25 that the Tohono O'odham Nation will not fund or operate  
26 the program in the interim while negotiations are still  
27 being conducted and no executed contract has been awarded  
28 by the Indian Health Service.

29 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
30 that the Tohono O'odham Nation's Officials, to wit: the  
31 Chairman, Vice Chairman and any designated official are  
32 hereby authorized to negotiate and execute the contract,

provided however, that any amendments affecting the  
funding or funding levels of the contract shall be  
submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council  
on the 11th day of July, 1990 at a meeting at which a quorum was  
present with a vote of 1,724.0 for; -0- against; -0- not voting;  
03 absent, pursuant to the powers vested in the Council by Section  
1 (f) of Article VI of the Constitution of the Tohono O'odham  
Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
