WHEREAS, the Tohono O'odham Legislative Council has reviewed and 13 approved the Management of Health Services Program FY 1991 14 recontract application and budget. 15

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative 16 Council that it does authorize and request the Public 17 Health, Indian Health Service to contract with the Tohono 18 O'odham Nation under P. L. 93-638 regulations and 19 procedures for the provision of services titled: 20Management of Health Services. 21

BE IT FURTHER RESOLVED that the duration of this contract shall 22 commence on October 01, 1990 through September 30, 1991. 23 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council 24 that the Tohono O'odham Nation will not fund or operate 25 the program in the interim while negotiations are still 26 being conducted and no executed contract has been awarded 27by the Indian Health Service. 28

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council 29 that the Tohono O'odham Nation's Officials, to wit: the 30 Chairman, Vice Chairman and any designated official are 31 hereby authorized to negotiate and execute the contract, 32
