

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Base Roll Addition)

RES. NO. 23-90

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the
2 Tohono O'Odham Nation provides that the Tohono O'Odham
3 Council can make additions and changes to the official
4 census rolls of the Sells and Gila Bend Reservations
5 dated January 1, 1937 and of the San Xavier Reservation
6 dated January 1, 1940, subject to the approval of the
7 Secretary of the Interior; and

8 WHEREAS, the Enrollment Committee has determined that the
9 following named person(s) were members of the Tohono
10 O'Odham Nation on the date of the respective census
11 rolls but that their name(s) had been inadvertently
12 omitted therefrom, and had recommended that their
13 name(s) be added to the rolls; and

14 WHEREAS, the Tohono O'Odham Council has reviewed the
15 recommendations of the Enrollment Committee and approves
16 thereof.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
18 Council that, subject to the approval of the Secretary
19 of the Interior, the name(s) of the following person(s)
20 be added to the official census rolls of the Sells, Gila
21 Bend or San Xavier Reservation, to wit:

25 BE IT FURTHER RESOLVED that the required approval be secured from
26 the Secretary of the Interior before their name(s) be
27 formally added to such rolls.

29 The foregoing resolution was passed by the Tohono O'odham
30 Council on the 5th. day of February 1990 at a meeting at which
31 a quorum was present with a vote of 1,660.5 for; 63.5 against;
32 -0- not voting; and 01 absent; pursuant to the powers vested in
the Council by Section 1 (a) of Article II and Section 1 (h) of
Article VI of the Constitution of the Tohono O'odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986, and
approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).


